Permission

This Office has received a communication from the office of Divisional Commissioner Kashmir alongwith an application moved by Asif Nabi Dar, Party President JK NDP requesting therein to organize the UT level Marathon Running Race at Pulwama on 16th November 2025 at 08 AM from Bandzoo Pulwama to Samboora Pulwama taking forward the dream of Hon'ble Prime Minister's Mission of Viksit Bharat. In this connection, a letter dated 10/10/2025 has been forwarded to Sr. Superintendent of Police Pulwama/ Awantipora for necessary action who in turn submitted report vide No. CS/Permission/2025/18632-37 Dated 08-11-2025 and No. CS/Per/Awt/2025/ 6340-42 dated 06/11/2025, conveying "No objection". Therefore, permission is granted in favour of Asif Nabi Dar, Party President JK NDP to organize the UT level Marathon Running Race at Pulwama on 16th November 2025 at 08 AM from Bandzoo Pulwama to Samboora Pulwama subject to the following conditions;

- I. That the participants shall ensure that there shall be no provocative speech/disharmony/sloganeering or displaying of any incriminating flags, poster or graffiti that invites Law and order problem or hurts the sentiments of other sections of community.
- II. That they shall not cause damage to any Govt/Private property.
- III. They shall not carry out any procession.
- IV. That the organizer shall cooperate with concerned police stations.
- V. That they shall not halt / obstruct the vehicular/ pedestrian movement during the programme.
- VI. No Anti-national speech shall be delivered/done during the Programme.
- VII. That the participants shall cooperate fully with the police in respect of security, traffic arrangements/check points.
- VIII. That no participant shall become part of any unlawful activity or cause breach of law & order.
- IX. That the route for organizing **the race shall be only one sided from Bandzoo-Boonura Crossing (CR)-Koil Crossing (CR)-Peaks Crossing-Pinglena-Pahoo-Kakapora Chowk - Kakapora Bridge to Samboora.**
- X. **That the Race should be concluded before 0900 hours sharp.**
- XI. That the administration reserves the right of cancelling this permission in case of any emergency situation without any further notice.
