Subject: Request to grant permission for organizing a running race from Fruit Mandi Prichoo Pulwama to Samboora Cricket ground on 02 October 2025 on the birthday of Father of the Nation, Mahatma Gandhi.

Permission

This office has received an application from Asif Nabi Dar, Party President JKNDP for organizing Running Race on 02-10-2025 from Fruit Mandi Prichoo Pulwama to Samboora Cricket Ground. In this connection, a letter has been forwarded to Sr. Superintendent of Police Pulwama/ Awantipora for furnishing of recommendations / comments who in turn submitted a report vide communication No.CS/Permission/2025/16917-22 dated 30/09/2025 and No. CS/Per/25/AWP/5742-45 dated 30-9-2025 respectively and conveyed no objection within their respective territorial jurisdiction, if permission is granted. Therefore, permission is granted to Asif Nabi Dar, Party President JKNDP for organizing Running Race from Fruit Mandi Prichoo Pulwama to Samboora Cricket ground on 02 October 2025 on the birthday of Father of Nation Mahatma Gandhi subject to the following conditions;

1. That no anti national speech shall be delivered / done and the organizers/ participants shall not damage any Govt/ public/ private property.
2. That the forbidden banners/ posters shall not be carried / hanged / pasted.
3. That no one shall raise / chant instigating / provocative slogans repugnant to any party/person/Religion / Caste/Organization.
4. That the organizers/ participants shall cooperate fully with the police in respect of security, traffic arrangements/ check points.
5. That no participant shall become part of any unlawful activity or cause breach of law and order.
6. That no such activity shall be carried out by the organizers / participants which can hurt the religions sentiments of any community.
7. That the route for running race shall be one sided from Fruit Mandi Prichoo Pulwama to Samboora Cricket ground
8. They shall not halt / obstruct any pedestrian / vehicular movement during the race.
9. That the organizers/ participants shall cooperate fully with the police station concerned.
10. That the running race shall be concluded before 0900 hours sharp.
