Subject: Immediate Disqualification of Four Top Participants and Withholding of Winning Prizes for Protocol Violations, Vandalism, and Defamation During the Pulwama "Grand Marathon".

PULWAMA, 17 November 2025: The Jammu and Kashmir National Democratic Party (JKNDP) expresses its deep regret to inform the public that despite clear, pre-event warnings and a mandatory code of conduct issued on November 14, serious violations of discipline and sportsmanship occurred during yesterday's "Grand Marathon" held on November 16, 2025.

Following a comprehensive review by the party leadership and the marathon monitoring committee, four top participants have been **immediately disqualified**, and all their **winning prizes, medals, and certificates** have been permanently withheld.

The disqualified individuals are identified as:

- 01. RAJINDER KUMAR**
 - 02. MOHD YASEEN**
 - 03. GHULAM HIDER**
 - 04. PANKAJ SHARMA**

Grounds for Disqualification and Charges:

Protocol Violations: These four individuals explicitly violated established sports protocols during the race and subsequently raised entirely **baseless, misleading claims regarding the integrity of the event.**

Destruction of Venue Infrastructure: When their false narratives were challenged on the spot by our volunteers, these individuals resorted to unruly behavior. Their actions, along with those of their associates, directly led to the deliberate sabotage and **destruction of essential infrastructure at the Samboora Pampore Cricket Ground venue, including hired tents and chairs.**

Malicious Comments Against the Party: In an attempt to divert attention from their misconduct, **these four individuals made highly offensive, false, and defamatory comments online and through social media platforms** aimed at tarnishing the reputation and political standing of the JKNDP.

Legal Action and Financial Recovery: The President of the JKNDP has confirmed that this act of senseless destruction forced the party to pay a penalty of ₹1,70,000 (One Lakh Seventy Thousand Rupees) to private vendors for the damaged property.

The party will maintain a policy of zero tolerance against such rowdy elements. Official complaints have been lodged with law enforcement agencies and the Cyber Crime Probe cell against RAJINDER KUMAR, MOHD YASEEN, GHULAM HIDER and PANKAJ SHARMA.

The party is handing over exhaustive digital evidence, including high-definition (HD) video footage and photographs, to the police. We have requested authorities to immediately identify, arrest, and initiate strict legal action against these four individuals, ensuring that the total financial loss of ₹1,70,000 is recovered directly from them.

The JKNDP remains committed to fostering safe, democratic, and community-driven engagements and will not be intimidated by individuals who seek to disrupt peace through violence and lies.
